Brief information items for practices

IMPORTANT - All Paperless Referrals from October 2018:

There is a national requirement that from October 2018 all GP referrals to consultant led first outpatient appointments must be made via the NHS e-Referral System (e-RS). If a referral does not have a UBRN number then the provider will not be paid. Any referrals received after 1/10/2018 not on eRS will be returned to practices to put on the electronic system. In line with this the new GP contract will make use of eRS a requirement.

To reduce the risk, a transition period will start where GP practices will be advised to start making sure all referrals are made by eRS with a proposed switch off date for non eRS referrals of 01/09/2018 or earlier if needed. More details will follow in the next few weeks. Please alert GPs and relevant administrative staff of this change. Any queries to OCCG.plannedcare@nhs.net

Gynaecology 2ww referrals and Colposcopy:

Patients are being referred on a 2ww pathway to colposcopy inappropriately which is causing problems. The [document here](#) indicates which patients should go where and the priority for the referral.
