EXTRA BOARD MEETING 20 JUNE TO CONSIDER CONSULTATION REPORT

The first meeting on Tuesday 20 June 2017 at Jubilee House, Oxford (9.30am to 11.30am) will receive and consider the consultation reports. The second on 10 August 2017 at the Examinations School, High Street, Oxford, is when OCCG expects to be able to make decisions on the proposed changes.

For 20 June meeting, you must submit questions to the Board by 9.30am on 19 June. Members of the Board will do their best to answer these questions during the meeting. However, any questions that remain unanswered at the end of the meeting will be answered in writing and put on the OCCG website within 20 working days. BE CLEAR ON CANCER - RESPIRATORY SYMPTOMS CAMPAIGN



Public Health England is running the campaign to encourage more people aged over 50 to get an earlier diagnosis for possible lung or heart disease. The key messages are:

- If people get out of breath doing things they were able to do, it could be a sign of lung or heart disease, or even cancer finding a condition early makes it more treatable: don't ignore it, tell your doctor
- If people have had a cough for three weeks or more, it could be a sign of lung disease, including cancer finding a condition early makes it more treatable: don't ignore it, tell your doctor

You can speak to trained staff and nurses as part of the campaign's roadshow on Monday 17 July and Tuesday 18 July (8am to 8pm) at The Chilterns, High Wycombe Frogmoor, High Wycombe.
