THE FLU JAB WILL HELP PROTECT YOU THIS WINTER



The annual flu vaccination campaign is underway and patients at risk from the condition are encouraged to have a free vaccination. These include:

- people aged 65 and over
- pregnant women
- people under 65 years in clinical 'at risk' groups
- children aged 2 to 3 years
- children in schools from reception to year 5
- carers and people in long stay residential homes.

IMPROVING THE NHS WEBSITE



NHS England and NHS Digital have been [improving nhs.uk](#), the UK's largest health website as part of their ambition to empower people to manage their healthcare. Changes include more accessible content, better mobile device experience, new content for helping people to manage long-term conditions, and improved page design.

As part of these improvements, users will no longer see the NHS Choices logo on the site. The URL remains the same, www.nhs.uk. Organisations are asked to replace existing references to 'NHS Choices' to 'the NHS website' when reasonably possible and cost-effective.

[Guidance](#) to help NHS organisations reference the NHS website correctly has been created. It includes downloadable graphics to replace the NHS Choices logo.
