

Professionals In Oxfordshire Safeguarding Training

The Oxfordshire Health services training strategy has been agreed to promote transferability of training when moving between local providers and optimise training provision across the local area. This version is aimed at those working in primary care.

All training is designed to meeting the intercollegiate requirements for health professionals, adult and children.

This passport is aimed at professionals and practitioners required to be at level 3 as defined in the statutory intercollegiate guidance documents.

Professionals working in standard primary care need the full adult and children requirements.

This document is a summary to share with your manager(s). You should save certificates, reflection on learning and other documents in your own appraisal or professional learning portfolio







Professionals In Oxfordshire Safeguarding Training -Childrens Level 3

4 hours induction activity within 3 months of starting practice in Oxfordshire plus 12 hours ongoing and updates required in 3 years.

50% learning should be participatory (involving interaction with others)

You should provide evidence for your practice manager/safeguarding lead of the following learning over a 3 year period and you should demonstrate some safeguarding learning each year

- 4 hours must be on core knowledge and skills (CPD, online course or F2F courses eg 'Safeguarding children level 3')
- 4 hours must be multi-agency (CPD, face to face courses, safeguarding activities eg attendance at case conferences, discussion with social workers, multiagency team meetings, audit of practice)
- 4 must be specialist topic based (see below)

<u>Professionals in Oxfordshire Safeguarding Training – Adults Level 3</u>

4 hours induction within 3 months of starting practice in Oxfordshire plus 8 hours every 3 years

50% learning should be participatory (involving interaction with others)

You should provide evidence for your practice manager/safeguarding lead of the following learning over a 3 year period and you should demonstrate some safeguarding learning each year

- 2 hours must be on core knowledge and skills (CPD, online course or face to face courses eg Adult Safeguarding level 3 course. Once in three years is sufficient for core knowledge and skills)
- 3 hours must be multi-agency (CPD, face to face courses, safeguarding activities eg professionals' meetings, practice meetings, audit of practice, chairing best interests meeting, discussions with SG Adults team)
- 3 hours must be specialist topic based
