



National Data Opt-out – EMIS Web

The National Data Opt- out was introduced on 25th May 2018. The aim is that all opt-outs are recorded through the website by 2020. Patients can record their opt-out at https://www.nhs.uk/your-nhs-data-matters/

Type 1 opt-out – read code 9Ndo/9Nu0

This is for the SCR or any other record extraction, and if added to the patient record will prevent their medical data being shared outside of the practice. At present this has to be recorded at the GP Surgery and the existing Type 1 opt-outs will remain in place until 2020 when further information will be issued.

Type 2 opt-out – Read code 9Nu4/9Nu5

This stops any confidential patient information collected across the health service being shared for research, future planning or any purpose other than patient care.
