### NHS App - are you ready?

A new <u>internal communications campaign</u> has been launched to raise awareness of <u>the NHS App</u> among healthcare staff. Patients at 95% of GP practices in England can now download and use all features of the NHS App.

A range of materials is available at <u>digital.nhs.uk/appconnect</u> to help practice managers brief staff and prepare systems, to ensure that practices and patients can make the most of the NHS App. Practice staff are encouraged to download the app to try it themselves, as the best way to learn about what it does so they can support patients.

#### **eConsult**



eConsult is an online triage system that enables patients to submit requests for support via online forms. This will help with the requirement that all patients will have the right to online consultations by April 2020 and video consultations by April 2021.

#### National criteria

We have received clarity nationally regarding the criteria for online consultations and it has been confirmed that providing email access to GPs does not meet the requirements to provide online consultations. Emailing is unlikely to support practices in leveraging benefits of online consultations, could increase workloads, may introduce new clinical risk and is unlikely to deliver a great patient experience.



Oxfordshire CCG is currently supporting the rollout of eConsult. We would like to hear from more practices which are ready to start the on-boarding process. If you would like to join one of the weekly webinars please contact Michael Carberry – Michael.carberry@webgp.com.



A national online implementation toolkit is available. It is an interactive document that provides a range of ideas and options for different professionals, including clinicians, at different points in their implementation journey. A shorter document, an evaluation form, is also available as a downloadable template. This is for use by GP practices to support them in measuring the impact of online consultations as a whole, from clinician and patient perspectives.

# Medicines A to Z; your help is needed



GP practice clinicians have the opportunity to help improve the Medicines A to Z on the NHS website (formerly NHS Choices). With two million visitors per month, this online directory offers patientfriendly information on commonly-used medications. The site also gives dosage guidance and advice on the self-management of side effects. Its aim is to improve medicines adherence, while helping to

reduce pressures on frontline staff.

### **GPIT Infrastructure**



#### PC refresh and Windows 10 trial

The GPIT PC and Windows 10 replacement programme has been trialled at 12 practices. Previously identified issues are substantially resolved and the rollout is now continuing as planned.

Early feedback suggests that the new computers offer significant speed differences over existing devices.

There are currently two practices in progress, and four scheduled, to have some of their PCs replaced and all updated with Windows 10.

Practices should expect to be contacted by Healthcare Computing or ABS to discuss scheduling the work if they have not already been approached.

#### **GP IT Futures - what is it?**

A new system to support procuring digital goods and services - GP IT Futures Digital Care Services (DCS) framework - will be introduced in January 2020. The DCS replaces the existing GP System of Choice (GPSoC) framework and will create an open market to allow CCGs and GPs to purchase systems that have been reviewed and meet the safety standards mandated by the Government. Systems that GP practices will be familiar with, including EMIS Web, InPS Vision, Microtest Evolution, Docman and iPlato, were all made available under GPSoC and, in the new year, the DCS will manage these and other solutions (NOTE: GPSoC is due to close on 31/12/2019 and the new solution will be in place by 01/01/2020).

#### What does this mean for me?

NHS Digital has started an exercise (in conjunction with SCW) to validate existing provisions that were purchased for GP practices in Oxfordshire under GPSoC and map them to an equivalent GPITF service. Further details will be circulated in due course, but if you have any specific queries please contact Steve Walker below.

# **Electronic Prescription Service (EPS)**

#### Phase 4



Practices are reminded that **EPS Phase 4** will be taking place in the coming months. This is a system update that will occur automatically and there is nothing for practices to do beyond informing prescribing staff about this change; it will simply happen. As a reminder, Phase 4 will default all 'non-nominated' prescriptions to be *signed* electronically. The patient will get a paper token to take to the pharmacy of their choice, which will then request the prescription from the spine by scanning the token barcode. More information about deployment dates will be provided as soon as they are confirmed.

# **GP** referral pro formas



# News and release notification November 2019 Keeping system pro formas up to date

Zip folders containing full sets of referral pro formas can be found on the <u>Referral Pro formas</u> page of the OCCG website.

The zip folder EMIS-Pro-formas, with a date stamp in the format YYYYMMDD, contains all of the EMIS referral pro formas currently in use. It can be saved, and imported in one step from within EMIS Web.

Also found on the Referral Pro formas page, the documents 'How to Cleanse your EMIS Pro forma library' and 'Working with GP Pro formas' give instructions on how to import the *single* zip folder and remove all old templates which have been replaced.

GPs and other staff should be discouraged from using their own local copies of pro formas as they can miss out on important changes, which may put the patient at risk.

Release of Vision pro formas is not always concurrent with the EMIS forms as they require further processing. The zip folder INPS-Pro-formas, with a date stamp in the format YYYYMMDD, contains all of the InPS Vision pro formas currently in use. Some of these pro formas have been upgraded to include SmartTags, which reduces the need to enter data by hand. They can be identified by a suffix of 's'.
